### **NEW BUSINESS**

Presentation: Glo Fiber Franchise in New Market

### LIAISON REPORTS

Mayor Burhans sent a letter to residents regarding the Town's FY23 audit and provided highlights and explanations on how the Town manages the money. The message was emailed and posted on the Town's website and Facebook page. He also reported the lines were removed from the south side of East Wainscot from MD 874 to Marley Street. There was concern that the lines were still visible. It was noted that the lines will blend over time with weather and traffic.

Councilman Kimble is still working on a plan for Messanelle Park. He also reported that the Rotary Club is having a flag-raising ceremony at Town Hall on Saturday, November 11, 2023, from 9:00 a.m. to 11:00 a.m.

Councilman Wright said decorating the lamp poles will start in the next few weeks. They will be decorated in red and green ribbons. He also wanted to remind everyone of the Christmas in New Market event on Saturday, December 2, 2023.

Councilman Weatherly reported on the Frederick County meeting held at New Market Middle School on Tuesday, November 7, 2023. The county sought input on the Frederick to New Market to Mt. Airy Pedestrian and Bicycle Connection. He said about 50 interested people came to inquire and provide input on the proposed bike project from Mt. Airy, New Market, and downtown Frederick. The attendees' average age was around 60, which was quite surprising, given the area's demographics. Frederick County planning representatives and consultant JMT answered constituents' questions with relative clarity. The big takeaway from the event was five such projects throughout Frederick County going through feasibility studies. However, only one will be selected for construction. The criteria used to determine which project moves on the construction are cost, complexity, environmental impact, study, and project length. Given this criterion, it is doubtful this path will get selected for construction.
