Update on Schedule 1 - England Woods Contributions and Road Improvements

Mayor Burhans reported the Town has received the \$600,000 payment outlined in Schedule 1 of the England Woods Annexation Agreement. He reviewed the agreement section outlining the possible uses for these funds and offered some Town needs that could use the funds for the Council to consider. Mr. Burnett provided an update on the current county and state road improvement planning projects. He advised there did not appear to be an immediate roadway project underway by either agency for which the \$600,000 might be used. The Council did not come to an agreement on the use of these funds.
