Public Hearing: Supplement to the 2010 Master Plan

On August 23, 2011 the notice of the Planning and Zoning Public Hearing was advertized in the Frederick News Post and reads as follows:

The Planning and Zoning Commission of The Town of New Market will conduct a public hearing on Thursday, September 8, 2011 at 7:00 p.m. at New market Town Hall, 39 West Main Street, New Market, MD for the purpose of receiving public comment on a proposed amendment to the Town's Comprehensive Plan.

Pursuant to Title 3 of Article 66B of the Maryland Annotated Code, the Commission has before it for consideration a recommendation to the Mayor and Council to amend the Municipal Growth Element of the Town's Comprehensive Plan, and the

Plan generally, to address various comments and recommendations received from planning agencies and others concerning the municipal growth element of the comprehensive Plan, and the comprehensive Plan generally.

The proposed amendment addresses various matters to be considered in a local comprehensive plan and municipal growth element under Article 66B, Section 3.05.

The complete text and content of the proposed amendment may be reviewed at Town Hall between 8:00 a.m. and 3:30 p.m., Monday through Thursday, and 10:00 a.m. on Friday.
