**2020 Market Rules**

**Vendor Location:**

All vendors will be on the brick sidewalk areas of Downtown New Market.

Vendors will not be allowed to block the doors to any buildings/homes

with their tents/tables/bags/boxes, etc... Please respect the frontage of homes/businesses at all times.

**Vendor Responsibilities:**

All vendors will be required to collect any trash and dispose of trash off premises of Town.

Be prepared and bring trash bags/cans to accommodate any trash from your patrons/staff.

All vendors will be spaced away from one another an appropriate distance for safety.

Please use all precautions when serving your patrons. Keep appropriate distance and avoid touching.

All vendors will be assigned their space by the Market Manager each Market Day.

Please stop by the Green Team table at 64 W. Main Street at the beginning of each Market Day

for space assignments. Vendors may bring 8 ft tables and chairs to fit a span of 15 ft max.

Tents encouraged, no larger than 10 ' x 10' --- please note sidewalk areas vary in width, please

be respectful to the areas.

All vendors are to unload all items at their assigned space, then move their vehicles before 9:45 AM to the parking lot at Town Hall - 40 South Alley, New Market - behind Main Street.

And if vendors would like to park (West) of the New Market Vol. Fire Dept. along Main Street they are permitted. If needed, additional parking will be provided - please ask the Market Manager.

Vendors will be set-up and ready to be exhibiting their products/services by 10 AM

and will not tear down until 2 PM. All vehicles of vendors to be moved to designated parking areas by 9:45 AM. No exceptions to this rule.

All vendor applications will be reviewed by the Market Manager and/or Green Team of New Market Members prior to approval. Some industries will not be allowed if they are not in the scope of the Farmer's Market vision and goals of serving the community.

No refunds will be processed for any reason. The Market is Rain or Shine, if the weather is too damaging, the Market Manager on call will close the Market early, but no refunds will be issued for that reason.
