

Town Council Minutes 39 W. Main Street

October 11, 2018 - 7:00 p.m.

The regular meeting of the Mayor and Council of the Town of New Market was held on Thursday, October 11, 2018 in the Town Hall, 39 West Main Street, New Market, MD with Mayor Winslow Burhans presiding. Members of the Council present were Shane Rossman, Scott Robertson, Mike Davies and Dennis Kimble. Jake Romanell was absent.

The cost estimate to replace the pipe is \$15,000. Mayor Burhans asked the Council to re-appropriate funds to the Dorchester/Royal Oaks/Wicomico project and take it out of the general fund.
