

# Town Council Minutes 39 W. Main Street

January 11, 2018 - 7:00 p.m.

The regular meeting of the Mayor and Council of the Town of New Market was held on Thursday, January 11, 2018 in the Town Hall, 39 West Main Street, New Market, MD with Mayor Winslow Burhans presiding. Members of the Council present were Shane Rossman, Mike Davies, Scott Robertson, and Jake Romanell. Dennis Kimble was absent. The Town Planner Pat Faux was also present.

CALL TO ORDER: The meeting was called to order at 7:01p.m.

#### APPROVAL OF MINUTES:

#### Mayor & Liaison Reports:

Mayor Burhans did not have anything to report on.

#### Councilman Rossman:

Councilman Rossman informed the Mayor and Council on a database program that he and the office staff have done a demonstration on called Constituent On. The software will allow us to have a streamline database for all of the town resident addresses, emails and can breakdown into individual neighborhoods if correspondences are needed. The price for the software is \$1,500 per year.

Burnett were satisfied with that. They also are addressing drainage problems and are working on talking with the county about fixing the water main covers. SHA has given the Town ADA waivers.

#### Councilman Davies:

Councilman Davies presented the details for the annual town dinner that will be held at Vintage Restaurant on February 21, 2018. The quote is for 50 people that were invited and the total cost will be \$1,920.00. As of now, there are 45 people confirmed going, which is a total of \$1,728.00.

# Bid Opening: 40 S. Alley Construction

Wormald Commercial Construction, LLC: \$132,619.00

Mayor Burhans announced that there should be a review committee to go over the bid details and report back at next month's council meeting for a recommendation to award the contract. The Mayor and Council agreed to the recommendation committee consisting of Chris Goettge, Shane Rossman, Dennis Kimble, and Karen Durbin as substitute for Dennis if he's unable to attend.

 Town Charter Amendment: Amending Article VII, Section 23-64 Purchasing and Contracts

Mayor Burhans gave an overview of the proposed amendment to the Town Charter. Currently since 2001, anything over \$5,000.00 has to be sent out to bid. The amendment will change that dollar amount to anything over \$15,000.00 to be sent out for bid. The Resolution # 2018-01 has been reviewed by Town Attorney, Bill Wantz.

**Decision:** Councilman Romanell made a motion to approve Charter Amendment Resolution No. 2018-01, Amending Article VII, Section 23-64 of the Charter of the Town of New Market providing for the manner of contracting for certain expenditures as amended by Resolution No. 01-02 (Charter Amendment No. 01-01).
