#### LIAISON REPORTS

Councilman Rossman is working with Remsburg Paving to identify road repairs/cracks for the upcoming budget submission. New bulbs for the streetlights that are out will be replaced soon, and bollards will be replaced in the next week or two. Councilman Rossman reported that the Town is losing K.A.T. Café' and the Town appreciated their service to the community. His family adopted a cat from them.

Councilman Wright reported on maintenance for 40 South Alley. The water heater was replaced, and the Town Hall was pressure washed. It is to be determined if the building will need the service yearly. He also reported on maintenance at Old Town Hall. He is looking for a replacement for the toilet seat in the men's public restroom. It is an odd shape, and he will work with Councilman Kimble to find a replacement. He also replaced a battery in the smoke detector and reported a crack in the women's public restroom ceiling.

Councilman Wright reported on April 12, 2022, HDC/ARC meeting. The following applications were discussed at the meeting: 1) 8 West Main Street filed for a fence repair and structure to enclose their dumpsters; 2) Blacksmith Shed demolition pre-submittal discussion with Ms. Fromer; 3) 114 Royal Oak filed for an addition; 4) 176 Wicomico Drive filed for a shed (tabled to the next meeting), and 4) 184 Wicomico Drive filed for a deck around an in-ground pool.

Councilman Weatherly wanted to personally thank Kelly Jarvis, Ashly Wright, Karen Cappiella, and Caitlin Moroney for helping with the Green Team. The team is coming together and thanked Councilman Wright for letting the team into the building for the meeting on April 13. Exciting things are coming out of the Green Team.

Councilman Kimble reported that Mesenelle Park was mulched. He will bleach the water at 40 South Alley. He gave an estimate of \$523.00 for a door in the conference room, and he and Councilman Wright gave an estimate of \$3,000 for the storage room to be completed. The service representative from Ehrlich Pest Control recommended that the weatherstripping on the bottom of the garage doors be replaced to keep small rodents out. Councilman Wright will work on replacing the weatherstripping.

Mayor Burhans reported that Pat Faux notified him today that the Governor announced the approval of the \$100,000 Public Safety Grant to build two parking pads located at 5<sup>th</sup> Alley (behind Old Town Hall) and 40 South Alley.
