He is working on getting a contractor for some projects at Town Hall. The heat works at Old Town Hall, but the water heater needs to be fixed. He thanked the Events Committee for doing an excellent job for the Christmas in New Market event.

Mayor Burhans reported that Fern Rodkey Electrical fixed lights throughout the Town.

Councilman Kimble discussed the proposal he received for uplighting the flag poles and minor electrical work needed at Town Hall. He is going to reach out for other proposals. Mayor Burhans reminded Councilman Kimble that the request for uplighting was made in the FY 22 budget and that a budget amendment will need to be made for the FY 23 budget.

Councilman Rossman reported meeting with Mr. Hubble and that snow removal would remain the same as last year. He is working with Hubble on a strategy to push snow on the newly paved alley without tearing them up. He also discussed the new sound equipment. Finetuning is needed, and carpets to help with the sound.

Public Comment: Claire Cawthon wanted to know if the Town received feedback from Mr. Olney on crosswalk improvements. She also asked if the Town would consider improving the crosswalks at the Derby, Old Town Hall, and Community Park with solar power push button flashing lights. Mayor Burhans suggested that Ms. Cawthon send an email.
