Councilman Wright discussed the issue of tractor-trailers turning left from Old New Market Road, Prospect Alley, to Main Street. He wants to devise a solution to stop them from turning at this location. Ellen Przybocki gave him two (2) Children at Play signs. He would like to put them up on his property.

Councilman Rossman reported that he and Caitlyn Moroney met with a business owner of a flower shop over at Old Town Hall. Town staff will follow up on questions. He said he would put the Stop sign back up at the Community Park and the Children at Play sign on South Federal. He also met with all municipalities in Frederick County regarding Public Open Space (POS) money. He sprayed the weeds on the sidewalks throughout Main Street and will remove the graffiti at the park. He announced that the Linganore-New Market Community Show is returning and requested a donation. By unanimous consent, Council approved a donation of \$150.00 to come out of the FY 24 budget. He also discussed the trash at Lawson's and at LOUYAA Fields.

Councilman Weatherly reported that he will have two (2) Resolutions to introduce at next month's meeting. 1) Green Team and 2) Walking Wheeling Wolves – Safe Walking around New Market.

Councilman Chance will report on the Planning and Zoning meetings at the next Town Council meeting.
