## Request for Change in CIP Appropriation for Investigation of New Public Area (Additional Off-Site Public Parking)

Mayor Burhans discussed the issue of changing the CIP for public parking, which was strictly limited to the Fire Department property. He suggested a change in the scope of the appropriation from looking at the Fire Department property to exploring other properties in Town to provide public parking. There has been some talk that the Fire Department is working on other ideas for their property. Some possible site ideas: 40 South Alley, property at the park, and the cul-de-sac on 8th Alley (apparently owned by Grange Hall). Before we started looking into this and hiring an abstractor for a title search, he wanted the Council's consent before proceeding. We will try to keep it under 5,000 square feet.

By unanimous consent, the Council agreed to change the CIP appropriation.

#### LIAISON REPORTS

Mayor Burhans reported on the 5K that occurred on Sunday, October 8, 2023. He said they had about 100 runners. It went very smoothly with the new race management company. He does not have final accounting currently.

Councilman Wright reported on the NMES Walk to School Day on Tuesday, October 3, 2023. County Executive Jessica Fitzwater walked with him, the mayor, and Councilman Weatherly.
